

Effective on products retailed on or after Jan 1, 2024

Register your product within 30 days of purchase to activate warranty.

Consumer Use

Unless otherwise stated in the materials that arrive with your product, U-Dig Excavators are warranted for five (5) years against defects in materials or workmanship, when put to ordinary and normal consumer use and maintained in accordance with manufacturers specifications. Warranty is limited to the replacement of parts and/or repair of the product. For the purposes of all the above warranties, "ordinary and normal consumer use" refers to non-commercial residential use and does not include misuse, accidents, or damage due to inadequate maintenance.

Commercial or Rental Use

U-Dig Excavators are warranted for two (2) years against defects in materials or workmanship, when used in either a commercial or rental environment.

This warranty does not cover the following items:

- 1. Machines or parts lost or damaged during shipment
- 2. Normal maintenance or adjustments after initial pre-service and set up is completed
- 3. Normal replacement of wearable or service parts
- **4.** Accessory items/parts not supplied by U-Dig Excavators
- **5.** Damages resulting from
 - a. Misuse, negligence, accident, theft, or fire
 - **b.** Use of improper or insufficient fuel, fluids, or lubricants
 - c. Use of parts or aftermarket accessories other than genuine U-Dig Excavators parts
 - **d.** Modifications, alterations, tampering or improper repair performed by parties other than an authorized dealer or repair center
 - **e.** Any device or accessories installed by parties other than an authorized U-Dig Excavators dealer or repair center.
- **6.** Tires are covered by the manufacturer of the tire and the warranty period specified by that manufacturer. Please contact the tire manufacturer for warranty on these items.

Engines

Engines are covered by U-Dig Excavators for a period of 90 days from in service date. After the 90 days all engines are covered by the warranty period specified by the engine manufacturer. **Engine** warranty must be registered at the engine manufacturers website to activate the warranty.
